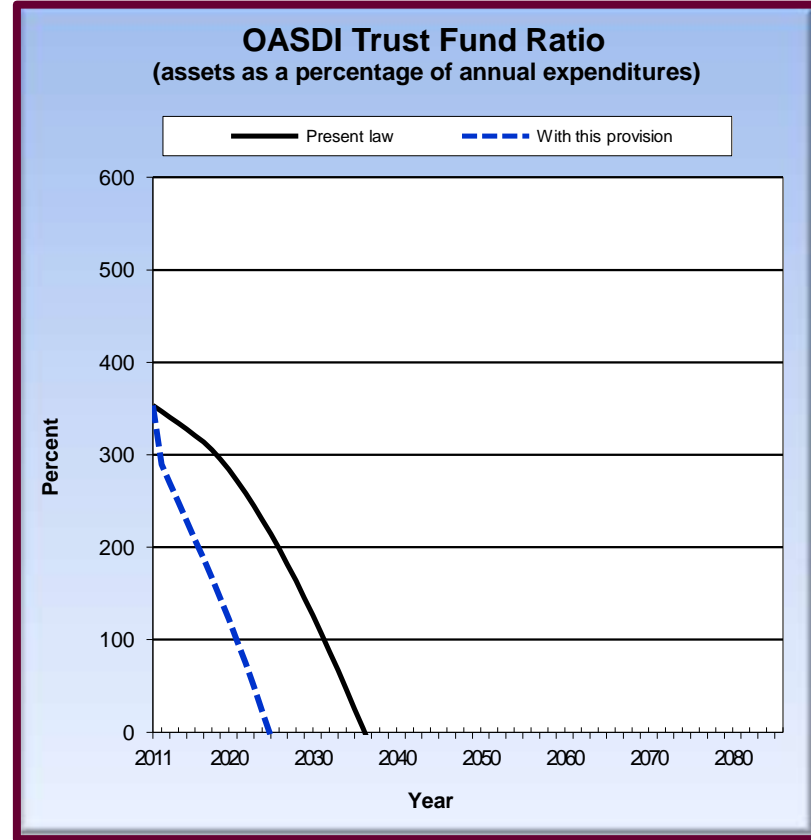
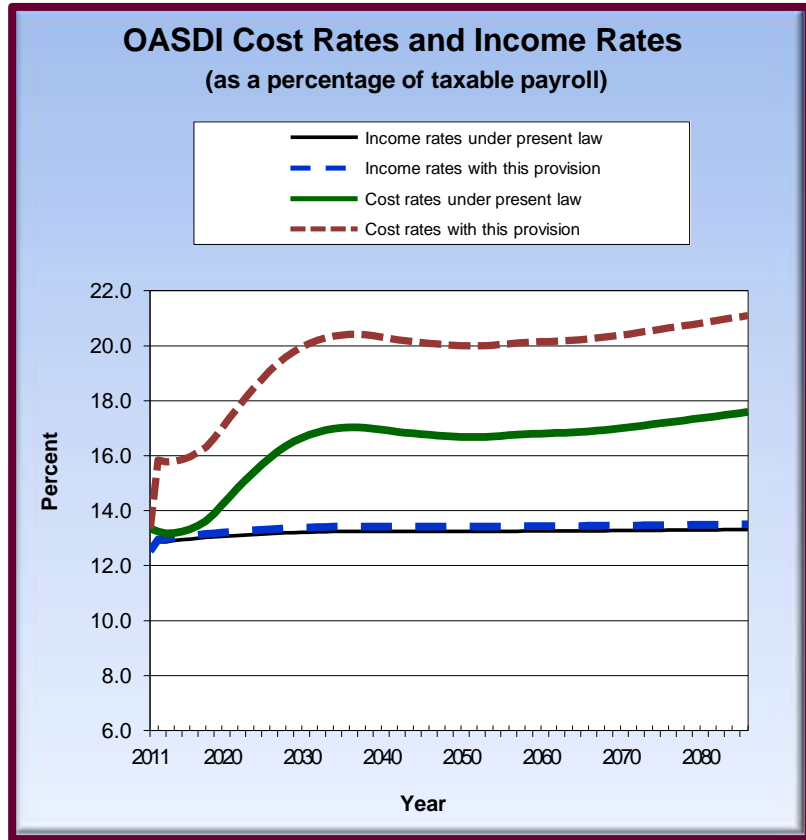


Summary Measures and Graphs
